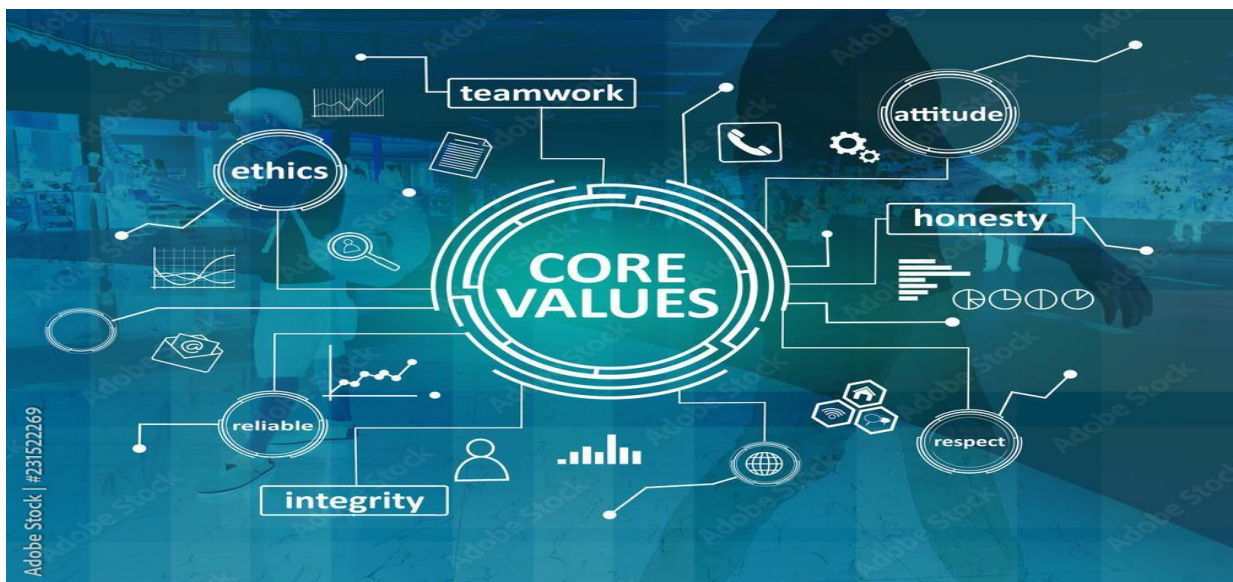

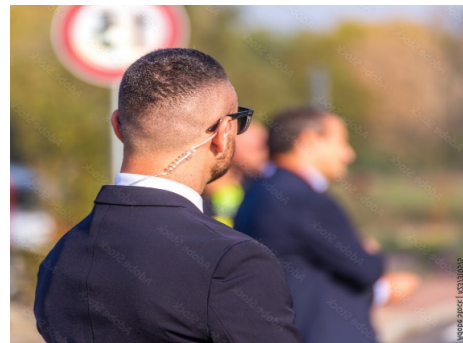

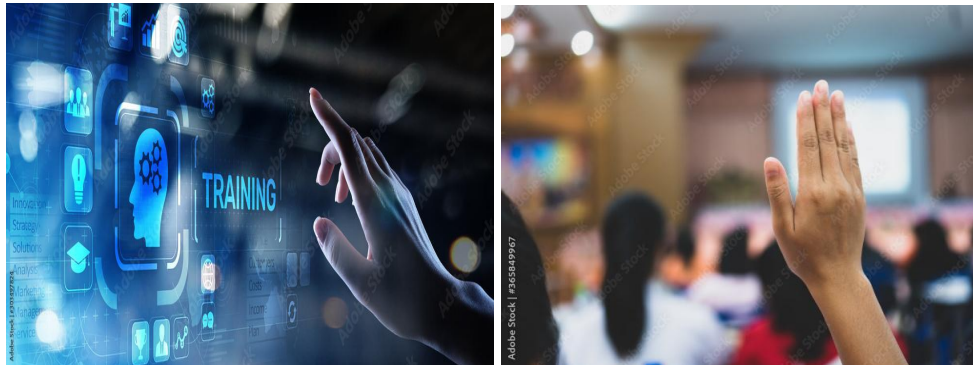
Our Training Program focuses on three key areas:

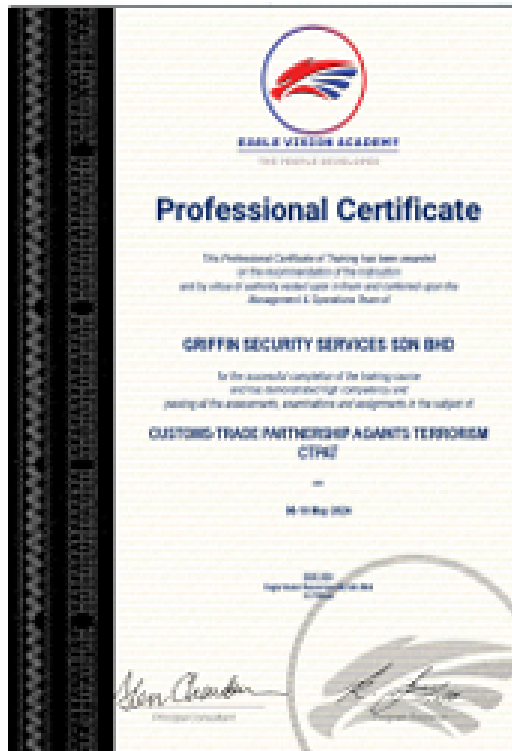
